**Consumers** within the meaning of the terms and conditions are natural persons to whom no commercial or independent vocational activity may be attributed .

### Validity

All sales, deliveries and services occur solely in accordance with these terms and conditions. Deviations from these, and any ancillary agreements are only valid if confirmed in writing by N-Tax Ltd.

### **Offers and prices**

All prices are given in EUR, and include VAT at the rate which is valid for Hungary at the time of the order.

### **Contract conclusion**

We pass on your order to one of our shipping dealer partners, who will then deliver on our behalf. So that you know who is sending you the goods, we will send you information regarding the job, stating the depot dealer, after receipt of your order. The purchase contract becomes effective upon receipt of delivery confirmation or delivery of the goods.

### **Retention of title**

The delivered goods remain N-Tax's property until they have been paid for in full. With regard to orders from operators, N-Tax Ltd. retains ownership of the goods until full payment of all claims from an ongoing business relationship. The operator is entitled to resell the goods in the ordinary course of business. It hereby assigns to N-Tax Ltd. all receivables at the invoiced amount which accrue to the operator through sales to a third party.N-Tax accepts the assignment. After the assignment, the operator is authorised to collect. N-Tax reserves the right to collect the claim as soon as the operator's payment obligations vis-à-vis N-Tax Ltd. are not properly fulfilled and is in default.

# Payment

Payment for the ordered goods will occur according to one of the methods specified when purchasing. In the case of default, HKM is entitled to charge default interest in accordance with the statutory provisions.

Orders can be paid by money transfering, or via PayPal.

## Shipping and shipping costs, delivery time

Orders are usually shipped by TransOFlex, or by partners of TOF.

Our administrator will inform you in email, about the shipping costs to your destination. It depends on which European zone you are, and the weight of your ordered items.

Please do not start the payment until we write you the total cost.

Goods are delivered within approx. 5-10 business days.

**Notification of withdrawal/right of withdrawal**You have the right to withdraw from this contract within 14 days without giving reasons. The withdrawal period is 14 days from the date on which you or a third party named by you (though not the carrier) takes possession of the goods.

To exercise your right of withdrawal, you must inform us (N-Tax Ltd. Attila u.11, Szeged, Hungary zipc.:6722 Tel. +36 30-714-7729, , email info@oxer-lovasbolt.hu) of your decision to withdraw from this contract by means of a clear explanation (e.g. a letter by post or email).

In order to make a valid withdrawal within the given period, it is sufficient for you to send notification that you wish to exercise your right of withdrawal before the withdrawal deadline.

### Effects of withdrawal:

If you withdraw from this contract, we are obliged to return to you all the payments that we have received from you, without delivery cost, at the latest within 14 days from the date on which the notification is received about your withdrawal from this contract. With regard to this repayment, we use the money transfering method. We may withhold the repayment until we have received the returned goods or until you have demonstrated that you have sent the goods back.

You must return or hand over the goods promptly and in any event no later than 14 days from the date on which you notify us of withdrawal from this contract; such goods are to be returned/handed in to N-Tax Ltd. OXER Riders Shop, Szeged, Szabadkai út 7.Napfénypark, 6725, Hungary. The deadline is deemed to have been met if you return the goods before the 14-day deadline. You will bear the direct cost of returning the goods.

You must pay for any deterioration in the value of the goods only if the deterioration in value is due to them being handled unnecessarily, as ascertained by a test of the nature, characteristics and functioning of the goods.

# Warranty, guarantee and notification of defects

All the goods from our shop are subject to statutory warranty rights for consumers. For items that are classified as second-hand, a one-year warranty is granted. Any further claims are excluded.

## Jurisdiction, miscellaneous

Hungarian law applies to the exclusion of the "PTK". If any provision of these general terms and conditions is invalid, the remaining provisions shall remain unaffected.
